## CIRCULAR

As all Assistant Directors, FCS&CA Department are aware that Ashoora (Muharram) is falling on 1st of October, 2017 and timely arrangements of distribution of foodgrains, fixation of rates of Essential Commodities in the Districts, market checking etc. are required to be taken in advance.

In this regard, review of advance arrangements with regard to Ashoora (Muharram) is being taken even at highest level and all Assistant Directors of FCS&CA are enjoined up to ensure the below noted instructions for immediate compliance:

- Timely lifting/dispatches and distribution of foodgrains i.e. Rice, Atta/Wheat, Sugar and K.oil, LPG Cylinders etc. to the rationees / beneficiaries including areas dominated by Shia population, Imam Baraas.
- Oil Marketing companies shall ensure availability of LPG cylinders in Shia dominant areas.
- Notification of the rates of all essential commodities in the Districts from Deputy Commissioners concerned (Chairperson of the District Level Committees on Price Fixation) as per SO 145

- (E) issued by Ministry of Consumer Affairs, Food and Public Distribution Department Government of India.
- 4) Regular Surveillance / market checking and necessary arrangements within the Districts/ Tehsils including punitive action against the defaulters, found indulged in over-pricing, under-scaling of hoarding as per the provisions contained in the Essential Commodities Act, 1955 and also in consonance with the Hoarding and profiteering prevention Ordinance, 2000 (1943 AD) (Ordinance No.XIX of 2000).

All Assistant Directors are thereby enjoined upon to take up the matter for constitution of Joint Market Checking Teams comprising of Police, Revenue, Legal Metrology and Health with the respective Deputy Commissioners and comply the above instructions in letter and spirit, submit regular reports to the Directorate for compiling and onward submission.

CIRCULAR No. 05 - FCS&CA of 2017 DATED:

As per decisions taken in the meeting chaired by the Hon'ble to review the arrangements being made by the Department for Muharram, and followed by the meeting, held under the Chairmanship of Hon'ble Minister for Food, Civil Supplies and Consumer Affairs, the following decisions were

- The Director, department of Food, Civil Supplies, Kashmir shall provide i). 2000 quintals of rice from the overall savings to the various districts. The respective Assistant Directors Shall furnish utilization certificates duly authenticated by the Shia Majlis of the respective areas.
- Director, Department of Food, Civil supplies and Consumer Affairs ii). Jammu/Kashmir are further directed to ensure availability of adequate quantity of K Oil to the Shia dominated areas, Imam Baraas as per demand from their overall quantity of K Oil for their respective divisions.
- It is further ordered that the Director, Food, Civil Supplies and Consumer iii). Affairs, Kashmir/Jammu shall constitute Marketing Checking Squad in all the areas dominated by the Shia Community across the State.
- Oil Marketing Companies shall ensure availability of LPG Cylinders in iv). the Shia dominated areas across the State.
