**NOTICE INVITING TENDER FOR PROVIDING OF MINI TRUCKS/  
AUTOMOBILES FOR CARRYING OF PDS RATION WITHIN JAMMU  
MUNICIPAL LIMITS FOR THE YEAR 2015-16**

Sealed tenders duly affixed with Rs.2/- revenue stamps are invited for and on behalf of the Governor of Jammu and Kashmir State from individuals and registered Transport Groups/Firms, Companies/Associations, in possession of valid service licence (only in case of Transport Groups, Firms/Associations) for transportation of foodgrains/sugar within the limits of Jammu Municipal Corporation for the year 2015-16 for supply of vehicles permitted to operate in the city of Jammu for carriage of rations to different areas within the aforesaid limits. The carriage rates per quintal may be quoted for city routes within Municipal limits, irrespective of the point of origination and destination. The tenders shall be superscribed as "**Tender for carriage of foodgrains/sugar etc.**" and accompanied by a Call Deposit Receipt (CDR) or Fixed Deposit Receipt (FDR) for Rs. **01.00 lacs** as Earnest Money pledged to the Director, CA&PD Department, Jammu, drawn from any Nationalized/Scheduled Bank.
