Subject: -Compassionate appointment of Mr. Harsh Khanna S/o Late. Sanjay Khanna R/o Ward No. 25, Q. No. 162 Rehari Colony, Jammu under SRO-43 of 1994.

Sanction is hereby accorded to the temporary appointment of Mr. Harsh Khanna S/o Late. Sanjay Khanna R/o Ward No. 25, Q. No. 162 Rehari Colony, Jammu, against an available post of MTS/Class-IV, in the pay level SL-I (14800-47100), in the Department of Food, Civil Supplies and Consumer Affairs Jammu in Divisional Cadre, in terms of SRO-43/1994, read with SRO-177 of 2014 dated 20.06.2014.

The appointee shall be on probation for a period of two years and shall report to the Directorate of Food, Civil Supplies and Consumer Affairs Department, Jammu, within a period of 21 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled abinito, in light of Government Circular No. 08-JK (GAD) of 2019 dated 04.12.2019. Further, the appointee shall be allowed to join only on the production of following certificates/documents in original:-

- 1. Academic Qualification.
- 2. Age/Eighth/Date of Birth Certificate.
- 3. Health Certificate issued by the Chief Medical Officer.
- 4. Dependent Certificate issued by the competent authority.
- 5. Valid Category Certificate, if any, applicable.
- 6. Certificate that if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of



proprietorship and stakes, if any, in such a self-employed unit/enterprise and recovery to be made and also personally monitor its recovery.

- 7. The inter-se-seniority of the appointee in the J&K Food, Civil Supplies and Consumer Affairs (Subordinates) Service shall be determined as per the J&K Civil Service (Classification, Control and Appeal) Rules, 1956.
- 8. The appointment of the appointee shall be cancelled ab-initio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.
- 9. Undertaking to the effect of taking responsibility to take care of all dependents and affidavit duly sworn before the 1<sup>st</sup> Class Judicial Magistrate from all other dependents affirming therein that they have no objection to the appointment of applicant under SRO-43 of 1994.
- 10. The appointment of the above appointee shall be subject to the outcome of writ petition(s), if any, pending before the Competent Court of law.

The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.11.2009.

The order of appointment shall be subject to cancellation abinitio, in case, at any stage it is found that the certificates/documents furnished by the appointee are fake/fictitious.
