**Subject: - Appointment of Junior Assistant (Divisional Cadre) under SRO-202 dated 30.06.2015, in the Department of Food Civil Supplies and Consumer Affairs, Jammu.**

Whereas, Administrative Department vide letter No. CAPD/Estt/98/2010 dated 30.07.2018 forwarded a selection list of six (6), Junior Assistants under Divisional Cadre Jammu in terms of SRO-202 dated 30.06.2015 for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions;

Whereas, recommendation of one Candidate namely Yaser Arafat S/o SS Mohd. Sadeeq R/o Nadyala Rajouri was kept withheld by the Service Selection Board;

Whereas, Administrative Department vide letter No. CAPD /Estt / 98 / 2010 dated 30.11.2018 forwarded a communication wherein the withheld recommendation of the above said candidate has been released by the J&K Service Selection Board vide No. SSB/Secy/Sel/2018/10718-20 dated 24.10.2018;

Whereas, Sh. Yaser Arafat S/o SS Mohd. Sadeeq R/o Nadyala Rajouri vide this Directorate notification issued under endorsement No. 382/G/4121-26 dated 31.12.2018 was asked to submit the original as well as self attested set of testimonials/certificates and undertakings in this Directorate within 10 days from the date of publication of this notification;

Whereas, in response to the said notification, the above said candidate submitted the requisite documents/testimonials/undertakings within the stipulated time;

Now, therefore, in view of the above, sanction is hereby accorded to the appointment of above mentioned candidate who has submitted his documents/certificates in the Directorate of Food Civil Supplies and Consumer Affairs Jammu (Divisional Cadre) as Junior Assistant in terms of SRO-202 dated 30.06.2015 with immediate effect.

The appointee shall report in the Direction office within a period of twenty one ( 21) days from the date of issuance of appointment Order.

The appointment of the Candidate as Junior Assistant shall be subject to the following conditions:-

1. Character/antecedent verification from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department. In case, anything adverse is reported against him, he shall have no right to claim his appointment as Junior Assistant in the Department of FCS&CA, Jammu and his appointment as such shall be deemed have been cancelled ab-initio;
2. Verification of the qualification/reserved category certificates from the competent authority;

The salary of the appointee shall not be drawn and disbursed by the concerned drawing and disbursing officer unless a satisfactory report in respect of (1) & (2) are received in his favour.

The salary of the candidate shall be regulated in terms of SRO 202 dated 30.06.2015.

The appointment of the Candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.11.2009.

The appointee shall be on probation for a period of five years and his confirmation is subject to successful completion of the same.

The appointee shall also give an undertaking in the shape of an affidavit duly attested by the 1<sup>st</sup> Class Magistrate to the extent that he will not apply for further transfer from the place/District in any case where he has been adjusted.

The appointment of the Candidate shall be subject to outcome of Writ petition(s), if any pending before any Hon'ble Court.
