Subject: - Initiation of Regular Departmental Action against Sh. Shabir Ahmed Magray, I/c TSO, FCS&CA Department Reasi with additional charge of I/c TSO Chasana, in case FIR No. 24/2012 P/S VOJ (Now ACB Udampur) dated 01.12.2012- appointment of Enquiry officer thereof.

Whereas, on the request made by Sh. Shabir Ahmed Magray, I/c TSO, Reasi with additional charge of I/c TSO Chasana duly forwarded by Assistant Director, FCS&CA, Department, Udampur, to the Directorate Vide No. AD/FCS&CA/RSI/2020-21/2813 dated 23.03.2022, his case for premature retirement was forwarded to the Administrative Department vide No. 180/PF/JA/2604-2605 dated 25.10.2021; and

Whereas, the Administrative Department has responded in the case, vide No. FCS&CA/Estt-S/83265/2008 dated 29.07.2022 that "The department is advised that the case of Mr. Shabir Ahmed Magray, I/c TSO Reasi, for Voluntary Retirement cannot be considered in terms of provision (i) below sub clause (ii) of Article 230 of the Jammu and Kashmir Civil Services Regulations"; and

Whereas, the Administrative Department has also desired to initiate RDA against the delinquent official on immediate basis, being Disciplinary Authority, as advised by General Administration Department; and

Whereas, Sh. Shabir Ahmed Magray, I/c TSO, attached in the Office of Assistant Director, FCS&CA, Udampur, was, accordingly, served with article of charges and directed to furnish his reply to the said charges, within 15 days of time; and

Whereas, the point No. 5 of standing guidelines for Regular Departmental Action (RDA) issued by General Administration Department, J&K, vide Circular No. 06-JK(GAD) of 2020 dated 03.02.2022 provides that

"After receiving the reply to the charges so framed against the officer / official, the same should be analyzed critically to arrive at a conclusion whether an Inquiry Officer is required to be appointed to inquire into the charges so framed or not;"

Whereas, the reply furnished by the official was examined and analyzed, in terms of the said guidelines and the same was found to be not satisfactory and substantive.

Now, keeping in view the above, Sh. Javed Iqbal Rather, JKAS, Deputy Director (Food and Rationing), FCS&CA, Department, Jammu is hereby appointed as an enquiry

officer to enquire into the charges framed against Sh. Shabir Ahmed Magray, I/c TSO, and furnish a report within a period of 15 days.
