

Sub: Allocation of PDS Sugar 2019-20 under National Food Security Act (NFSA) for PHH Category for distribution on the eve of Ramadan/Eid-ul-Fitr.

Sanction is hereby accorded to the allocation of PDS Sugar 2019-20 under National Food Security Act (NFSA) for PHH Category on the eve of Ramadan/Eid-ul-Fitr in favour of Assistant Directors, FCS&CA Jammu Division as per the breakup shown as under. The Assistant Director, Trade & Store, FCS&CA, Jammu shall issue allocated quota from the saving of sugar available in different stores of Jammu division strictly as per the break up shown against each in below table:-

ADs of Jammu District shall submit the indent to AD Trade and Store strictly within the figures of Total PHH souls on portal (AAY+PHH)

The above allocation is however subject to the following conditions:

 The scale of PDS Sugar shall be 500 gms. per soul to all the eligible souls under PHH category of NFSA;

2. All dispatches should be through PoS and distribution should be atleast 70% Aadhaar

 A quantity of 9833.00 Qtls of sugar available over & above the monthly requirement shall be transported from Jammu to valley only through the trucks of JKSRTC/CHT with a view to have least transportation cost to be borne by the Director, FCS&CA Kashmir.

 Assistant Director (T&S) FCS&CA Jammu shall have close coordination with Director FCS&CA Kashmir in lifting and transporting the surplus sugar available with Directorate of FCS&CA, Jammu. 5. The stock of sugar from Jammu be transported directly to the sale outlets of the individual districts to cut additional transportation/handling charges.

6. The short fall of stocks in distribution, if any, shall be ensured to be compensated by

Aadhaar based distribution through PoS devices.

7. It shall be ensured that sale proceeds realized on account of distribution of sugar to the PHH consumers shall be credited to the Revolving Fund Account (Sugar) soon after realization and no outstanding is left on this account.

8. The sale proceeds realized by the Director FCS&CA, Kashmir on account of distribution of the actual quantity of sugar lifted from the Directorate of FCS&CA, Jammu shall be transferred to the Revolving Fund Account (Sugar) operated by the Director FCS&CA,

9. The Assistant Directors shall immediately after distribution of the stock send a compliance report to this Directorate with respect to the actual quantity of sugar distributed and the amount of sale proceeds realize on this account and intimate whether any stock remained undistributed due to any specified cause.

10. It should be ensured that the Sugar be distributed/supplied in time among the rationees without

any re-appropriation /diversification;

11. Lifting-Offtake statement and Utilization Certificate as per the prescribed format may be sent to the Directorate. Besides this, Assistant Directors shall furnish the information regarding daily lifting and dispatches of sugar to the Directorate on the following day without any fail;

12. The Assistant Directors shall be personally responsible for proper distribution of sugar amongst the

bonafide consumers as per the valid ration tickets and scale.

13. Assistant Directors shall keep strict vigil against pilferage and overcharging at the sale centre;

14. The under scaling of sugar if any shall be treated as misappropriation and embezzlement and erring

officer shall be liable for punitive action under rules;

15. All Assistant Directors shall ensure implementation of the above terms and conditions in letter & spirit. Deviation, if any, shall attract disciplinary action against the defaulting officers/officials.
