Whereas, this Directorate had received Selection list of Junior Assistants alongwith waiting list under different categories from J&K Service Selection Board letter No. SSB/Secy/Sel/2019/269-75 dated 09.01.2019 through Administrative Department vide letter No. CAPD/Estt/59/2011 dated 13.02.2019;

Whereas, the waiting list of (06) candidates under Open, RBA, SC and ST categories have been operated vide this Directorate Order No. 08-DFCS&CAJ of 2020 dated 10.01.2020;

Whereas, the waiting list of ALC category was not operated due to non availability of eligible candidate under ALC category;

Whereas, vide this Directorate Order No. 170-DFCS&CAJ of 2020 dated 18.08.2020, Sh. Arun Kumar S/o Sh. Jagdish Lal R/o Kangri, Sunderbani, Rajouri figuring at S.No. 01/ALC was appointed as Junior Assistant in the Department of Food, Civil Supplies and Consumer Affairs, Jammu in the Pay Level-4 (Rs. 25500-81100) with the condition that ***"As per the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department, the candidate, if fails to join within stipulated period of 21 (twenty-one) days from the date of issuance of appointment order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice"***;

Whereas, Sh. Arun Kumar failed to join within the period of 21 days from the issuance of appointment order and his appointment is deemed to have been cancelled ab-initio as per General Administration Department Circular No. 08-JK(GAD) of 2019 dated 04.12.2019;

Whereas, vide this Directorate letter No. 396/G/415-417 dated 11.02.2021, Administrative Department was requested to impart the necessary directions for operating waiting list in favour of Sh. Deepak Sharma S/o Sh. Ram Krishan Sharma R/o Village Pallanwala, Tehsil Khour, District Jammu against **Sh. Arun Kumar** figuring at **S.No. 01/ALC**;

Whereas, Administrative Department vide letter No. CAPD/Estt/59/2011 dated 03.03.2021 has conveyed administrative approval for issuance of formal appointment order in favour of Mr. Deepak Sharma S/o Ram Krishan Sharma R/o Pallanwala, Akhnoor Jammu (01/ALC) as Junior Assistant, Divisional Cadre Jammu in Pay Level-4 (Rs. 25500-81100) on the standard terms and conditions as per rules by way of operating waiting list in ALC category;

Now, therefore, sanction is hereby accorded to the temporary appointment of Sh. Deepak Sharma S/o Ram Krishan Sharma R/o Pallanwala, Akhnoor Jammu as Junior Assistant (Divisional Cadre) who is figuring next in order of merit under ALC Category as per the waiting list provided by J&K Service Selection Board communicated vide No. SSB/Secy/Sel/2019/269-75 dated 09.01.2019 in the pay level-4 (25500-81100) in the Department of Food, Civil Supplies and Consumer Affairs, Jammu under SRO-202 dated 30.06.2015 with immediate effect by way of operation of waiting list.

The appointment of the above said candidates shall be subject to fulfillment of the following conditions: -

- 1) The appointee shall report to this Directorate of FCS&CA, Jammu within a period of 21 days from the date of issuance of this order failing which his appointment order shall deemed to be cancelled in light of Government Circular No. 08-JK(GAD) of 2019 dated 04.12.2019.
- 2) The appointee shall be allowed to join only on production of the following certificates in original: -
 - a) Academic/Technical Qualification Certificates / Marks sheets.
 - b) Matriculation/Date of Birth Certificate.
 - c) Health Certificate issued by the Chief Medical Officer concerned.
 - d) Permanent Resident Certificate issued by the competent authority.
 - e) No Loan Certificate from DIC.
 - f) No Loan Certificate of Self-employment.
 - g) Relevant valid Category Certificate issued by the competent authority.

The appointment of the candidate as Junior Assistant in the Department shall further be subject to the following conditions that: -

(a) Each appointee shall give an undertaking in the shape of an affidavit duly attested by Judicial Magistrate 1st Class to the effect that in case adverse report about his character/antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department, he shall have no right to claim his appointment as Junior Assistants in the Department of FCS&CA, Jammu and his appointment, as such shall be deemed to have been cancelled ab-initio;

(b) Verification/genuineness of the qualification certificates, Reserved Category certificates, State Subject Certificate and the recognition of institute(s) from the concerned issuing authorities.


The Salary of the appointee shall not be drawn and disbursed by the concerned drawing and disbursing officer(s) unless a satisfactory report in respect of (a) & (b) above is received in his favour.

The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.11.2009.

The appointee shall be on probation for a period of five years and their confirmation is subject to successful completion of same.

In case at any stage it emerges that the certificates/any relevant documents furnished/produced by the appointee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the appointee(s).

The appointment of the candidate(s) shall be subject to outcome of Writ Petition(s), if any, pending in any Court of the competent Jurisdiction.
