Subject:- Conducting Enquiry against the storekeeper, Foodstore Kahara-Suspension thereof.

Whereas, a complaint was lodged in the office, with video viral on internet, against the storekeeper Kahara, for dumping huge amount of ration And;

Whereas, there was hue and cry in the public with regards to the said issue And;

Whereas, undersigned conducted the tour of the District and the delinquent official was called in the meeting at Doda to explain his position And;

Whereas, the storekeeper was not able to explain his position (i.e. receipt and issue), regarding dumping of ration in the said stores.

Therefore, pending enquiry into the conduct, Mr. Abdul Rashid Zargar storekeeper Foodstore, Kahara, is placed under suspension with immediate effect. He will remain attached in the office of Assistant Director Kishtwar, during the period of his suspension.

Moreover, sanction is hereby accorded to the conduct of following committee for conducting a departmental enquiry, on the complaints against Tehsil Supply Officer/Storekeeper, Kahara, Doda for not distributing food grains/wheat amongst beneficiaries, despite stocking the same in the store. The committee is free to enquire any other related issue reported to or found from record, if any.
