The appointee shall report in the Direction office within a period of 21 days from the date of issuance of appointment order. In case of failure of appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled abinitio without any further notice.

The appointee(s) shall be allowed to join only on production of the following certificates in original:

- 1. Academic/Technical Qualification Certificates.
- 2. Matriculation/Date of Birth Certificate.
- 3. Health Certificate issued by the competent authority.
- 4. Permanent Resident Certificate issued by the competent authority.

- 5: Certificate from the District Industries Centre (DIC) and District Employment & Counseling centre to the effect that no loan under self employment Scheme has been taken by the appointee.
- Relevant valid Category Certificate issued by the competent authority if any.

The appointment of the candidate(s) as Junior Assistants in the Department shall further be subject to the following conditions that:-

- (a) The appointee shall give an undertaking in the shape of an affidavit duly attested by Judicial Magistrate 1st Class to the effect that in case adverse report about his/her character/antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department, he/she shall have no right to claim his/her appointment as Junior Assistants in the Department of FCS&CA, Jammu and his/her appointment, as such shall be deemed to have been cancelled ab-initio;
- (b) Verification/genuineness of the qualification certificates, Reserved Category certificates, State Subject Certificate and the recognition of institute(s) from the concerned issuing authorities.

The Salary of the appointee shall not be drawn and disbursed by the concerned drawing and disbursing officer(s) unless a satisfactory report in respect of (a) & (b) above are received in their favour.

The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.11.2009.

The appointee shall be on probation for a period of two years and their confirmation is subject to successful completion of same.

In case at any stage it emerges that the certificates/any relevant documents furnished/produced by the appointee is fake/fictitious, the appointment orders shall be cancelled abinitio and criminal proceedings shall be initiated against the appointee.
