Now, therefore, in view of the above, sanction is hereby accorded to the appointment of above mentioned candidates four (4) candidates who submitted their documents/certificates in the Directorate of Food Civil Supplies and

Consumer Affairs Jammu (Divisional Cadre) as Junior Assistants in terms of SRO-202 dated 30.06.2015 with immediate effect.

The appointee(s) shall report in the Direction office within a period of twenty one (21) days from the date of issuance of appointment Order.

The appointment of the Candidates as Junior Assistants shall be subject to the following conditions:-

- 1. Character/antecedent verification from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department. In case, anything adverse is reported against him/her, he/she shall have no right to claim his/her appointment as Junior Assistant in the Department of FCS&CA, Jammu and his/her appointment as such shall be deemed have been cancelled ab-initio;
- 2. Verification of the qualification/reserved category certificates from the competent authority;

The salary of the appointee(s) shall not be drawn and disbursed by the concerned drawing and disbursing officer(s) unless a satisfactory report in respect of (1) & (2) are received in their favour.

The salary of the candidates shall be regulated in terms of SRO 202 dated 30.06.2015.

The appointment of the candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.11.2009.

The appointee(s) shall be on probation for a period of five years and his/her confirmation is subject to successful completion of the same.

The appointee(s) shall also give an undertaking in the shape of an affidavit duly attested by the $\mathbf{1}^{\mathrm{st}}$ Class Magistrate to the extent that they will not apply for further transfer from the place/District in any case where they have been adjusted.

The appointment of the Candidates shall be subject to outcome of Writ petition(s), if any pending before any Hon'ble Court.
