In Pursuance to the decisions taken in the review meeting chaired by the Hon'ble Minister for Consumer Affairs and Public Distribution and Tribal Affairs Department on 18.10.2015 at Canal Road Guest House, Jammu, a broad based Vigilance/Monitoring and inspection squad has been constituted with below comprises Officers/Officials to safe guard the interests of consumers, for checking any losses/pilferage and to conduct monitor and inspection of proper distribution of the PDS food grains, Kerosene Oil, sugar and any other commodity that is included under Essential Commodities Act:-

**The prime responsibilities of the squad are as under :-**

- i). Squad/team will monitor the movement of vehicle/s or any other mode or means that is/are used for transportation, distribution/storage/dumping of PDS material, Kerosene Oil and its distribution among the PDS beneficiaries;
- ii). Squad will enquire, investigate and take measures which will help in monitoring the pilferage/loss to Govt. exchequer and recommend punitive action against those officials and non officials involved in such loss/es;
- iii). Squad will have the mandate to move/shift a transport vehicle/means of transport beyond the determined route for the purpose of investigation such as determining laden/unladen weight/contents and nature of goods or for any other purpose which is or may become part of monitoring or investigation. Provided that such an act is duly recorded in writing;
- iv). Squad will have the mandate to seize the records/goods, take samples for determining contents/ quality or for any other purpose which is in the interest of exchequer/public health and consumers at large;
- v). Squad shall devise a mechanism for receiving complaints, if any, regarding the misappropriation/leakage in PDS, if any. For this the helpline number of Directorate level i.e, 1967 as well other numbers of the Assistant Directors across Jammu Division will be widely published for general awareness and receiving timely inputs;
- vi). Squad will also take action against hoarding, black marketing and assist the consumer affairs wing of the department as and when required.
- vii). Squad is also responsible to check the premises of any commercial establishment(s) dealing with Essential commodities.
- viii) The team(s) is to be provided additional assistance by the CA&PD officers /officials as and when required in emergency basis. Besides team will seek assistance of executive and law enforcing agencies.
- ix) The squad / team will be in proper uniform while discharging duties as already ordered.

x) Any other assignment that is assigned to the squad/team by the Director, CA&PD, Jammu.

xi) The squad / team will submit weekly reports on the issue(s).
