It is also enjoined upon all PIOs/APIOs to dispose of the application(s) in accordance with the provisions contained in the RTI Act. Besides, all public authorities particularly the PIOs shall furnish the information to information seeker after obtaining required details from APIOs (TSOs)/field functionaries, as the case may be and after

consolidation of same forward the required information through registered post directly to the applicant by the PIOs and not by the APIOs.

Besides, it is also mandatory for the public authorities of CA&PD that while disposing of RTI applications, they shall invariably indicate their name(s), designation, contact No. etc including name and address of First Appellate Authority, in case the information seeker is not satisfied with the information provided.


