Sanction is hereby accorded to launching of "Prime Minister's Food Supplementation for Priority Households Scheme" in Jammu & Kashmir, to augment the monthly food requirements of Priority Households category under Public Distribution System with the following norms:-

- The scheme shall be admissible only in respect of Priority i) Households category under Public Distribution System.
- Total admissible allocation in respect of a priority Household ii) under the scheme shall be in such a manner that the entitlement under all the schemes in PDS, including this scheme, does not exceed 35 kgs.
- The beneficiary wise additional allocation under the scheme shall iii) be as under:-

Priority Household with beneficiary number	Additional admissible scale allowed (in kgs)
1	5
2	10
3	10
4	10
5	10
6	5
7 & above	0



- iv) Both the Directors shall utilize their Revolving Fund (Foodgrains) Account, for meeting the financial requirements under the scheme after following formalities, prescribed for operation of Revolving Funds.
- v) The foodgrains for the scheme shall be sourced from Open Market Sale Scheme Domestic (OMSS-D) of the Department of Food & Public Distribution, Government of India.
- vi) Rice shall be distributed under the scheme to begin with, as only rice is presently available to the Department under OMSS-D.
- vii) The sale price of rice shall be 25/- rupees per kg under this scheme.

It is further ordered that:-

- (i) In case some Priority Households and AAY families need further foodgrains they shall register their demand with the Department which, however, shall be made available by the Department at the market price that shall include actual costs of procurement of foodgrains plus handling charges.
- (ii) As and when, the Department of Food & Public Distribution, Government of India, restarts sale of wheat under OMSS(D), the Department shall explore option of inclusion of the wheat and wheat flour, under the scheme with the approval of the Competent Authority, after the sale prices are decided in consultation with the Finance Department.
